

Dubois High Country 3 on 3 Basketball Tournament Waiver

SIGNATURES ON THE ENTRY FORM INDICATE AGREEMENT WITH THE TERMS OF THIS WAIVER

In consideration of being permitted to participate in the 2008 Dubois High Country 3 on 3 Basketball Tournament (referred to herein as EVENT), conducted by We Do Events, Inc., the player or his/her parent or guardian (if the player is under 18 years of age), for himself/herself, his/her personal representatives, heirs and next of kin, acknowledges, agrees and represents that he/she has or will inspect the facilities and equipment to be used in the Events, and if he/she believes that any unsafe conditions exist, he/she will immediately advise an Event official of such conditions and will refuse to participate until such conditions are corrected.

Damage caused to Event equipment or Event facilities by a player will be the responsibility of the player.

VOLUNTARY WAIVER AND RELEASE: The player (or his/her parent or guardian), by signing the entry form, hereby releases, waives and discharges, and covenants not to sue We Do Events, Inc. (referred to herein as HOST), all Events sponsors, the owner(s) of the Event premise(s), and charities and each of their agents, directors, officers, employees, attorneys, insurers, servants, agents, parents, divisions, subsidiaries, predecessors, successors and representatives (referred to herein as EVENT ORGANIZERS) from any and all liability to the player, his/her personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claims and demands of every kind and nature, for damages actual and consequential, past, present and future, arising out of or in any way related to the Events, including but not limited to any claims of personal injury or death from playing in the Events or the loss of personal property by theft or otherwise during the Events, any publicity relating to the Events, any prizes awarded, and any loss of collegiate or high school eligibility as a result of participation in the Events, whether caused by the negligence of the Event Organizers or otherwise.

ELIGIBILITY: Before registering all participants should contact their coach or athletic director and ask how your eligibility would be affected, if at all, by registering for the Event and receiving an Event trophy or prize.

INTENT TO DECEIVE: Any entry information provided by the player on the entry form that proves false or presented with intent to deceive (as documented and deemed false or deceptive by the EVENT ORGANIZERS) will result in the termination of participation in the tournament, forfeiture of the their team's entry fee, tournament bracket placement, and awards.

INDEMNIFICATION AND HOLD HARMLESS: The player (or his/her parent or guardian), by signing the entry form, hereby agrees to indemnify and save and hold harmless the Event Organizers and each of them from loss, liability, damage or cost they may incur due to the player's participation in the Events, whether caused by the negligence of the Event Organizers or otherwise.

ASSUMPTION OF RISK: The player (or his/her parent or guardian), by signing the entry form, hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of the Event Organizers or otherwise while participating in or observing the Event.

PUBLICITY: The player (or his/her parent or guardian), by signing the entry form, hereby consents to the use without compensation, of his/her name and/or likeness, biographical material and/or voice in publicity and advertising concerning the Events, any Event sponsors and/or their promotion in any and all media and throughout the world.
