SUBSCRIBER may not resell broadband service to outside parties under this agreement.

SUBSCRIBER will have the option to purchase or lease a Router. Router lease will include damage inherent to defect of equipment, damage due to lightning or power surge, accidental damage caused by **SUBSCRIBER**. Router lease is for a minimum of 1-year or Early Termination Fee may be assessed.

SUBSCRIBER may upgrade to a higher speed Service (Replacement Service) without incurring an early termination or network reconfiguration charge by signing a new agreement. However, the minimum term of the Replacement Service shall be equal to the remaining term of the existing Service Agreement and for a monthly service charge equal to or greater than that of the existing Service with the terms and conditions of this Agreement continuing in full effect; **SUBSCRIBER** may convert existing Service to a lower priced Service by agreeing to a minimum service term equal to or greater than the original term of the existing Service; Downgrades to a lower speed Service may result in the assessment of an Early Termination Fee.

SUBSCRIBER ACKNOWLEDGES READING, AND AGREES TO ALL TERMS AND CONDITIONS OF THIS AGREEMENT, WHICH TERMS AND CONDITIONS ARE PART OF AND HEREBY INCORPORATED INTO THIS AGREEMENT BY THIS REFERENCE.
